Owned and operated by Mr. Ryan Rump, "Rump's Road Rules" has become the number one choice for driver education in Southeast Iowa. Students must be at least 14 years of age and **MUST** possess a **valid instructional driving permit** prior to the beginning of class. Other pertinent information is as follows:

- There will be **two sessions** offered at Burlington High School for students in the spring of 2020.
- The first spring session will begin Monday, March 2nd. This session will include classroom hours each Monday and Thursday from 6-9pm. There will be no classroom sessions the week of spring break (week of March 16th). The last day of class will be Thursday, April 9th.
- The second spring session will begin Monday, April 13th. This session will include classroom hours each Monday and Thursday from 6-9pm, with the last day of class being Thursday, May 14th.
- There are 30 hours of classroom time scheduled for each session per state requirements. There will be one make up class scheduled for each session based on instructor and student availability.
- Driving times for both sessions will be arranged by the instructors on the first day of class. **All efforts will be made to accommodate your busy schedule.**
- The cost of the course will be \$335.00. A \$170.00 deposit is required with registration. Burlington students who qualify for a reduced/free rate should contact the Burlington HS activities office for payment information and write "free" or "reduced" at the bottom of their registration form. Deposits are refundable if notification is given ten days prior to the start of driver education. Refunds of any kind **will not be issued** once driver education has initiated. The balance of tuition will be collected on the first day of class (**please plan accordingly**). Please make checks payable to **Triple R Driving School L.L.C.** Certificates of completion will not be issued until all financial obligations have been fulfilled.
- **Confirmation of enrollment will be sent via text message 5-7 days before the first day of class. If you have any questions, please contact Ryan at 319-470-6975.**

Operating Agreement for Triple 'R' Driving School

It is the intent of the Triple R Driving School and affiliates of the company to provide instruction and experience to students of all ages in driver education. Instructors of Triple R Driving School are certified teachers in the state of Iowa. The format of the school may vary depending on the time of year (spring, summer, fall, etc.), although instructional content will remain the same.

Iowa State requirements will be met or exceeded:

1. Length of the day in the classroom may not exceed 180 minutes.
2. Number of classroom hours will be a minimum of 30 hours.
3. Students will receive 240 minutes of substance abuse education.
4. Students will receive a minimum of 20 minutes of railroad crossing safety.
5. Students will be provided instruction relating to the organ donation under the Uniform Anatomical Gift Act.
6. Two or more students **will be scheduled** for all behind-the-wheel instruction.
7. 30 minutes per session, 60 minutes per day is the maximum a student may drive in one day.
8. The minimum number of times a student will drive in a dual control automobile during the entire course without simulation or range is 12.
9. A maximum of 360 minutes of range instruction may be substituted for behind-the-wheel instruction.
10. All driver education instructors, with the exception of behind-the-wheel instructors, must hold a valid Iowa secondary teaching license and the Driver Education endorsement.

In the unfortunate event of an accident/collision with a student behind the wheel, Triple 'R' will ask that the student or family of the student cover half of the deductible for collision repairs (\$500.00 deductible for collision insurance; \$250.00 responsibility to student or student's family).

It is our intent that all students will complete the course at program's end. However, students with excessive absences, tardies, deficient driving abilities or disruptive behavior (as judged by the instructor) will be dismissed from the program or be required to obtain more driving experience before being issued a certificate of completion. Additional driving experience may be obtained with the instructor or other persons meeting state requirements as at the discretion of the instructor. Additional driving with the instructor will be \$40.00 per hour.

Upon completion of the course, students will be awarded a certificate of completion. The certificate will allow them eligibility for an intermediate driver's license under the Graduated License System of the state of Iowa, and also allow them eligibility for a school permit (if eligibility criteria are met). All other Graduated License requirements must be met (see graduated license information from the Department of Transportation). Lost certificates of completion can be duplicated with a \$40.00 fee.

Any student not showing up for their scheduled drive during the course of drivers education will be subject to a \$40.00 fee.
