Triple 'R' Driving School, "Rump's Road Rules" has become the number one choice for driver education in Southeast Iowa. Students must be at least 14 years of age and **MUST** possess a **valid instructional driving permit** prior to the beginning of class. Other pertinent information is as follows:

- There will be two online class options for students in the summer of 2026. In order to participate, students will need a strong internet connection at home, a computer with a working speaker and camera, and a valid e-mail address.
- **The first option will be a hybrid session (combination of zoom classroom and independent study) beginning on Tuesday, July 6th.** This session will include classroom hours via a virtual classroom starting at 8am on July 6th, 13th, 20th and 27th. Additional classroom work will be assigned for students to complete independently under the guidance of our classroom instructor; students will be given deadlines for when to complete the assigned classroom material. Classroom work will meet or exceed 30 hours of classroom instruction.
- **The second option will be fully self paced/independent study and will start on Sunday, July 19th.** There will be one zoom session in the evening on July 19th to discuss our platform and answer questions. Classroom work will meet or exceed 30 hours of instructional time.
- **Driving times for both sessions will be arranged via a zoom session with Mr. Ehlers on Friday, July 17th at 9am. We will schedule drive times based on student and instructor availability. A zoom link will be sent to students in advance of this meeting.**
- The cost of the course will be \$350.00. A \$175.00 deposit is required with registration. Central Lee students who qualify for a reduced/free rate should write "free" or "reduced" at the bottom of their registration form. The reduced rate is \$210; there is no fee for those qualifying for the free rate. Deposits are refundable if notification is given prior to the start of driver education. Refunds of any kind **will not be issued** once driver education has initiated. The balance of tuition will be collected before certificates of completion are distributed (**please plan accordingly**). Please make checks payable to **Triple R Driving School L.L.C.**

Operating Agreement for Triple 'R' Driving School

It is the intent of the Triple R Driving School and affiliates of the company to provide instruction and experience to students of all ages in driver education. Instructors of Triple R Driving School are certified teachers in the state of Iowa. The format of the school may vary depending on the time of year (spring, summer, fall, etc.), although instructional content will remain the same.

Iowa State requirements will be met or exceeded:

1. Length of the day in the classroom may not exceed 180 minutes.
2. Number of classroom hours will be a minimum of 30 hours.
3. Students will receive 240 minutes of substance abuse education.
4. Students will receive a minimum of 20 minutes of railroad crossing safety.
5. Students will be provided instruction relating to the organ donation under the Uniform Anatomical Gift Act.
6. Two or more students **will be scheduled** for all behind-the-wheel instruction.
7. 30 minutes per session, 60 minutes per day is the maximum a student may drive in one day.
8. The minimum number of times a student will drive in a dual control automobile during the entire course without simulation or range is 12.
9. A maximum of 360 minutes of range instruction may be substituted for behind-the-wheel instruction.
10. All driver education instructors, with the exception of behind-the-wheel instructors, must hold a valid Iowa secondary teaching license and the Driver Education endorsement.

It is our intent that all students will complete the course at program's end. However, students with excessive absences, tardies, deficient driving abilities or disruptive behavior (as judged by the instructor) will be dismissed from the program or be required to obtain more driving experience before being issued a certificate of completion. Additional driving experience may be obtained with the instructor or other persons meeting state requirements as at the discretion of the instructor. Additional driving with the instructor will be \$50.00 per hour.

Any student not showing up for their scheduled drive during the course of driver education will be subject to a \$50.00 fee.
