Two spring sessions for all students to choose from!!

Triple 'R' Driving School, "Rump's Road Rules" is a great driver education alternative for students in eastern and southeast Iowa. Students must be at least 14 years of age and **MUST** possess a **valid instructional driving permit** prior to the beginning of class. **Classroom sessions will be conducted on-line via Zoom and Google Classroom this spring. Driving times will be scheduled based on instructor and student availability (each student will drive six hours with our instructors).** Other pertinent information is as follows:

- There will be **two sessions** offered for students through Clinton Community Schools in the spring of 2022.
- The first spring session will begin on Monday, February 21st. Classroom hours will run from 4:00-7:00pm on the following dates: Feb. 21st through Feb. 25th and Feb. 28th through March 3rd. We will run a Saturday class on Feb. 26th from 8-11am. A make up class could be scheduled at a time TBD if necessary.
- The second spring session will begin on Monday, March 28th. Classroom hours will run from 4:00-7:00pm on the following dates: March 28th through April 1st and April 4th through April 7th. A Saturday class will be held from 8-11am on April 2nd. A make up session could be scheduled at a time TBD if necessary.
- Driving times for these sessions will be scheduled based on student and instructor availability once classroom sessions begin (six hours of driving time will be scheduled).
- The tuition for the class will be \$365. A \$200.00 deposit is required with registration. Clinton school district students who are eligible for free/reduced lunches are also eligible for free/reduced driver education and should indicate that on the bottom of the form you turn in. Deposits are refundable if notification is given prior to the start of driver education. Refunds of any kind **will not be issued** once driver education has initiated. The balance of tuition will be collected on the first day of class (**please plan accordingly**). Please make checks payable to **Triple R Driving School L.L.C.** Certificates of completion will not be issued until all financial obligations have been fulfilled.
- Those wishing to enroll in a spring class should bring their completed registration form and deposit to the Clinton High School main office, or mail registration forms and deposit to the above address, or email completed registration forms to: triplerdrivingschool@gmail.com
- **Confirmation of enrollment will be sent via text message approximately 3-5 days before the first day of class. If you have any questions, please contact Ryan at 319-470-6975.**

Operating Agreement for Triple 'R' Driving School

It is the intent of the Triple R Driving School and affiliates of the company to provide instruction and experience to students of all ages in driver education. Instructors of Triple R Driving School are certified teachers in the state of Iowa. The format of the school may vary depending on the time of year (spring, summer, fall, etc.), although instructional content will remain the same.

Iowa State requirements will be met or exceeded:

1. Length of the day in the classroom may not exceed 180 minutes.
2. Students will receive at minimum 30 hours of classroom instruction and 6 hours of behind-the wheel training.
3. Students will receive 240 minutes of substance abuse education.
4. Students will receive a minimum of 20 minutes of railroad crossing safety.
5. Students will be provided instruction relating to the organ donation under the Uniform Anatomical Gift Act.
6. The minimum number of times a student will drive in a dual control automobile during the entire course without simulation or range is 12 (30 min sessions) or 6 (one hour sessions).
7. A maximum of 360 minutes of range instruction may be substituted for behind-the-wheel instruction.
8. All driver education instructors, with the exception of behind-the-wheel instructors, must hold a valid Iowa secondary teaching license and the Driver Education endorsement.

In the unfortunate event of an accident/collision with a student behind the wheel, Triple 'R' will ask that the student or family of the student cover half of the deductible for collision repairs (\$500.00 deductible for collision insurance; \$250.00 responsibility to student or student's family).

It is our intent that all students will complete the course at program's end. However, students with excessive absences, deficient driving abilities or disruptive behavior (as judged by the instructor) may be dismissed from the program or be required to obtain more driving experience before being issued a certificate of completion. Additional driving experience may be obtained with the instructor or other persons meeting state requirements as at the discretion of the instructor. Additional driving with the instructor will be \$40.00 per hour.

Upon completion of the course, students will be awarded a certificate of completion. The certificate will allow them eligibility for an intermediate driver's license under the Graduated License System of the state of Iowa, and also allow them eligibility for a school permit (if eligibility criteria are met). All other Graduated License requirements must be met (see graduated license information from the Department of Transportation). **Lost certificates of completion can be duplicated with a \$40.00 fee.**

Any student not showing up for their scheduled drive during the course of driver education will be subject to a \$40.00 fee.
