Triple 'R' Driving School, "Rump's Road Rules" is a fast and affordable driver education alternative for students in Eastern Iowa. Students must be at least 14 years of age and **MUST** possess a **valid instructional driving permit** prior to the beginning of class. Other pertinent information is as follows:

- There will be one online/virtual class offered for students in the winter of 2024. In order to participate, students will need a strong internet connection at home, a computer with a working speaker and camera, and a valid e-mail address.
- The online winter session will begin on Saturday, Jan. 6<sup>th</sup> at 8am (until 10am). Other dates online classroom sessions will be conducted are: Jan. 15<sup>th</sup> (4-6pm), Jan. 22<sup>nd</sup> (4-6pm), Jan. 29<sup>th</sup> (4-6pm) and Feb. 3<sup>rd</sup> (8-10am). These classroom session will be required; additional classroom work and assignments will be assigned and completed by the student at their own pace (deadlines will be given).
- Driving times for this session will be arranged once we begin the classroom sessions. We will schedule drive times based on student and instructor availability.
- The cost of the course will be \$355.00. A \$175.00 deposit is required with registration. Northeast and Easton Valley students who qualify for a reduced/free rate should write "free" or "reduced" at the bottom of their registration form. **Northeast students who qualify for the free or reduced tuition should visit the Northeast Central Office to fill out the required waiver (see Julene Spain). Payments can be send in with the registration form to the above address, or payments can be sent via Venmo to: Ryan-Rump-2**
- Deposits are refundable if notification is given prior to the start of driver education. Refunds of any kind **will not be issued** once driver education has initiated. The balance of tuition will be collected before certificates of completion are distributed (**please plan accordingly**). Please make checks payable to **Triple R Driving School L.L.C.**
- Mr. Craig Reuter will be the classroom instructor/moderator for this session. Mr. Reuter and Ms. Jolene Sparks will be the behind the wheel instructors for this session.

## Operating Agreement for Triple 'R' Driving School

It is the intent of the Triple R Driving School and affiliates of the company to provide instruction and experience to students of all ages in driver education. Instructors of Triple R Driving School are certified teachers in the state of Iowa. The format of the school may vary depending on the time of year (spring, summer, fall, etc.), although instructional content will remain the same.

### ***Iowa State requirements will be met or exceeded:***

1. Length of the day in the classroom may not exceed 180 minutes.
2. Number of classroom hours will be a minimum of 30 hours.
3. Students will receive 240 minutes of substance abuse education.
4. Students will receive a minimum of 20 minutes of railroad crossing safety.
5. Students will be provided instruction relating to the organ donation under the Uniform Anatomical Gift Act.
6. Two or more students **will be scheduled** for all behind-the-wheel instruction.
7. 30 minutes per session, 60 minutes per day is the maximum a student may drive in one day.
8. The minimum number of times a student will drive in a dual control automobile during the entire course without simulation or range is 12.
9. A maximum of 360 minutes of range instruction may be substituted for behind-the-wheel instruction.
10. All driver education instructors, with the exception of behind-the-wheel instructors, must hold a valid Iowa secondary teaching license and the Driver Education endorsement.

**In the unfortunate event of an accident/collision with a student behind the wheel, Triple 'R' will ask that the student or family of the student cover half of the deductible for collision repairs (\$500.00 deductible for collision insurance; \$250.00 responsibility to student or student's family).**

It is our intent that all students will complete the course at program's end. However, students with excessive absences, tardies, deficient driving abilities or disruptive behavior (as judged by the instructor) will be dismissed from the program or be required to obtain more driving experience before being issued a certificate of completion. Additional driving experience may be obtained with the instructor or other persons meeting state requirements as at the discretion of the instructor. Additional driving with the instructor will be \$40.00 per hour.

Upon completion of the course, students will be awarded a certificate of completion. The certificate will allow them eligibility for an intermediate driver's license under the Graduated License System of the state of Iowa, and also allow them eligibility for a school permit (if eligibility criteria are met). All other Graduated License requirements must be met (see graduated license information from the Department of Transportation). Lost certificates of completion can be duplicated with a \$40.00 fee.

Any student not showing up for their scheduled drive during the course of drivers education will be subject to a \$40.00 fee.
