Owned and operated by Mr. Ryan Rump, "Rump's Road Rules" has become the number one choice for driver education in Southeast Iowa. Students must be at least 14 years of age and MUST possess a valid instructional driving permit prior to the beginning of class. Due to COVID-19 pandemic, the summer classroom sessions will be conducted on-line via Zoom and utilizing Google Classroom and Canvas. Driving times will be scheduled in accordance with school district approval taking into account guidance from government officials as it pertains to COVID-19. Other pertinent information is as follows:

- There will be **two sessions** offered through the Knoxville school district for students in the summer of 2021.
- The June session will begin Monday, June 7<sup>th</sup> and conclude on Friday, June 18th. This session will include on-line classroom hours each weekday (M-F) from 8-11am. A make up class could be offered if necessary on a date TBD. In order to participate, students will need a strong internet connection at home and a computer with a working speaker and camera. Driving times for this session will be scheduled based on student and instructor availability once class begins.
- > The second summer session will begin Monday, July 26th and conclude on Friday, August 6th. This session will include classroom hours each weekday (Mon-Fri) for three hours (8:00-11:00am). A make up class could be offered if necessary on a date TBD. In order to participate, students will need a strong internet connection at home and a computer with a working speaker and camera. Driving times for this session will be scheduled based on student and instructor availability once class begins.
- Driving times for both sessions will be arranged by the instructors. All efforts will be made to accommodate your busy schedule.
- The cost of the course will be \$305.00. A \$150.00 deposit is required with registration. Knoxville students who are eligible for free/reduced lunches are also eligible for free/reduced driver education and should indicate that on the bottom of the form you turn in. Deposits are refundable if notification is given prior to the start of driver education. Refunds of any kind will not be issued once driver education has initiated. The balance of tuition will be collected on the first day of class (please plan accordingly). Please make checks payable to Triple R Driving School L.L.C. Certificates of completion will not be issued until all financial obligations have been fulfilled.
- > Mr. Tom Grimm and Ms. Paige Bolton will be the classroom and in-car instructors for both sessions.
- Confirmation of enrollment will be sent via text message approximately 2-4 days before the first day of class. If you have any questions, please contact Mr. Rump at 319-470-6975.

## **Operating Agreement for Triple 'R' Driving School**

It is the intent of the Triple R Driving School and affiliates of the company to provide instruction and experience to students of all ages in driver education. Instructors of Triple R Driving School are certified teachers in the state of Iowa. The format of the school may vary depending on the time of year (spring, summer, fall, etc.), although instructional content will remain the same.

## Iowa State requirements will be met or exceeded:

- 1. Length of the day in the classroom may not exceed 180 minutes.
- 2. Students will receive at minimum 30 hours of classroom instruction and 6 hours of behind-the wheel training.
- 3. Students will receive 240 minutes of substance abuse education.
- 4. Students will receive a minimum of 20 minutes of railroad crossing safety.
- 5. Students will be provided instruction relating to the organ donation under the Uniform Anatomical Gift Act.
- 6. The minimum number of times a student will drive in a duel control automobile during the entire course without simulation or range is 12 (30 min sessions) or 6 (one hour sessions).
- 7. A maximum of 360 minutes of range instruction may be substituted for behind-the-wheel instruction.
- 8. All driver education instructors, with the exception of behind-the-wheel instructors, must hold a valid Iowa secondary teaching license and the Driver Education endorsement.

In the unfortunate event of an accident/collision with a student behind the wheel, Triple 'R' will ask that the student or family of the student cover half of the deductible for collision repairs (\$500.00 deductible for collision insurance; \$250.00 responsibility to student or student's family).

It is our intent that all students will complete the course at program's end. However, students with excessive absences, deficient driving abilities or disruptive behavior (as judged by the instructor) may be dismissed from the program or be required to obtain more driving experience before being issued a certificate of completion. Additional driving experience may be obtained with the instructor or other persons meeting state requirements as at the discretion of the instructor. Additional driving with the instructor will be \$40.00 per hour.

Upon completion of the course, students will be awarded a certificate of completion. The certificate will allow them eligibility for an intermediate driver's license under the Graduated License System of the state of Iowa, and also allow them eligibility for a school permit (if eligibility criteria are met). All other Graduated License requirements must be met (see graduated license information from the Department of Transportation).

Any student not showing up for their scheduled drive during the course of driver education will be subject to a \$40.00 fee.
