### ***TWO GREAT SUMMER OFFERINGS TO CHOOSE FROM!!***

Triple 'R' Driving School, "Rump's Road Rules" is a great choice for driver education in Eastern Iowa. Students must be at least 14 years of age and **MUST** possess a **valid instructional driving permit** prior to the beginning of class. Other pertinent information is as follows:

- There will be two summer driver education courses from which to choose from through the Northeast and Easton Valley school districts. All summer classroom sessions will be conducted face to face; six hours of in person driving time per student will be arranged once class begins and will be scheduled based on student and instructor availability.
- The first summer driver education session will begin Monday, June 5th. This session will include classroom hours each weekday (Monday-Friday) from 7am-10am for two weeks **at Northeast High School in Goose Lake**. Each student will also be scheduled for 6 driving hours outside of classroom time arranged by the instructor, with the goal of being finished with all drives by June 28th.
- The second summer driver education session will begin Thursday, July 6th. This session will include classroom hours each weekday from 7am-10am for two weeks (ending July 20th) **at Easton Valley High School in Preston**. Each student will also be scheduled for 6 driving hours outside of classroom time arranged by the instructor, with the goal of being finished with all drives by July 29th.
- The cost of the course will be \$355.00. A \$175.00 deposit is required with registration. Easton Valley or Northeast High School students who are eligible for free/reduced lunches are also eligible for free/reduced driver education and should indicate that on the bottom of the form you turn in. Deposits are refundable if notification is given prior to the start of driver education. Refunds of any kind **will not be issued** once driver education has initiated. The balance of tuition will be collected on the first day of class (**please plan accordingly**). Please make checks payable to **Triple R Driving School L.L.C.** Certificates of completion will not be issued until all financial obligations have been fulfilled.
- Easton Valley students can drop off their registration form and deposit to the Easton Valley High School office, or mail the registration and deposit to the above address. Northeast and non Easton Valley students can mail the registration and deposit to the above address.
- Mr. Craig Reuter will be the classroom instructor for this session. Mr. Reuter and Ms. Jolene Sparks will be the in-car instructors for this session.

## Operating Agreement for Triple 'R' Driving School

It is the intent of the Triple R Driving School and affiliates of the company to provide instruction and experience to students of all ages in driver education. Instructors of Triple R Driving School are certified teachers in the state of Iowa. The format of the school may vary depending on the time of year (spring, summer, fall, etc.), although instructional content will remain the same.

### ***Iowa State requirements will be met or exceeded:***

1. Length of the day in the classroom may not exceed 180 minutes.
2. Students will receive at minimum 30 hours of classroom instruction and 6 hours of behind-the wheel training.
3. Students will receive 240 minutes of substance abuse education.
4. Students will receive a minimum of 20 minutes of railroad crossing safety.
5. Students will be provided instruction relating to the organ donation under the Uniform Anatomical Gift Act.
6. The minimum number of times a student will drive in a dual control automobile during the entire course without simulation or range is 12 (30 min sessions) or 6 (one hour sessions).
7. A maximum of 360 minutes of range instruction may be substituted for behind-the-wheel instruction.
8. All driver education instructors, with the exception of behind-the-wheel instructors, must hold a valid Iowa secondary teaching license and the Driver Education endorsement.

**In the unfortunate event of an accident/collision with a student behind the wheel, Triple 'R' will ask that the student or family of the student cover half of the deductible for collision repairs (\$500.00 deductible for collision insurance; \$250.00 responsibility to student or student's family).**

It is our intent that all students will complete the course at program's end. However, students with excessive absences, deficient driving abilities or disruptive behavior (as judged by the instructor) may be dismissed from the program or be required to obtain more driving experience before being issued a certificate of completion. Additional driving experience may be obtained with the instructor or other persons meeting state requirements as at the discretion of the instructor. Additional driving with the instructor will be \$40.00 per hour.

Upon completion of the course, students will be awarded a certificate of completion. The certificate will allow them eligibility for an intermediate driver's license under the Graduated License System of the state of Iowa, and also allow them eligibility for a school permit (if eligibility criteria are met). All other Graduated License requirements must be met (see graduated license information from the Department of Transportation). **Lost certificates of completion can be duplicated with a \$40.00 fee.**

Any student not showing up for their scheduled drive during the course of driver education will be subject to a \$40.00 fee.
