Triple 'R' Driving School is designed to offer an affordable and professional driver education option for students in Marion and Jasper County. Students must be at least 14 years of age and **MUST** possess a **valid instructional driving permit** prior to registration. Other pertinent information is as follows:

- The summer and fall classroom sessions will be held in person (face to face) at Newton High School (Room 11).
- The State of Iowa **MANDATES** six hours of behind the wheel instruction and 30 hours of classroom instruction.
- There will be two summer sessions offered during the summer of 2026. The first summer session will begin on Monday, June 8th. Classes will run for two hours each weekday (M-F) from 8-10am for three weeks. One make-up session will be offered at a time TBD.
- The second summer session will begin on Monday, July 6th. Classes will run for two hours each weekday (M-F) from 8-10am for three weeks. One make-up session will be offered at a time TBD.
- ****Please note: Free and Reduced waivers for this session will go by the 26-27 qualifications**
- There will be one fall session offered beginning on Monday, October 26th. Classes will run for three hours each weekday (M-F) from 3:30-6:30pm for two weeks. One make-up session will be offered at a time TBD.
- ****Students can miss one classroom session and still be eligible for a certificate of completion (will need to attend make up class). A driving schedule will be arranged by the instructors based on student and instructor availability.**
- The cost of the course will be \$375. A \$150 deposit is required with registration (no deposit is required for those eligible for free tuition; a \$150 payment is required for those qualifying for reduced tuition). Deposits are refundable if notification is given prior to the start of driver education. Refunds of any kind **will not be issued** once driver education has initiated. The balance of tuition will be collected on the first day of class (**please plan accordingly**). Please make checks payable to **Triple R Driving School L.L.C.** Certificates of completion will not be issued until all financial obligations have been fulfilled.
- **Newton school district students who are subject to a free or reduced rate should indicate that on the registration form they return for enrollment (write "Free" or "Reduced" on form; those qualifying for reduced lunch should include a \$150 payment).**
- Newton students enrolling can mail registration forms to the above address OR drop off registration form and deposit in the Newton High School main office or activities office.
- All driving will originate and finish from Newton High School.
- Mr. Eric VanderVelden, Ms. Mindy DeKoning, Ms. Lorraine Kalkhoff, Ms. Nicole George and Officer Lovan will be the in-car instructors for this session. Ms. Doree Ward will be the classroom instructor for all sessions.

Operating Agreement for Triple 'R' Driving School

It is the intent of the Triple R Driving School and affiliates of the company to provide instruction and experience to students of all ages in driver education. Instructors of Triple R Driving School are certified teachers in the state of Iowa. The format of the school may vary depending on the time of year (spring, summer, fall, etc.), although instructional content will remain the same.

Iowa State requirements will be met or exceeded:

1. Length of the day in the classroom may not exceed 180 minutes.
2. Number of classroom hours will be a minimum of 30 hours.
3. Students will receive 240 minutes of substance abuse education.
4. Students will receive a minimum of 20 minutes of railroad crossing safety.
5. Students will be provided instruction relating to the organ donation under the Uniform Anatomical Gift Act.
6. Two or more students **will be scheduled** for all behind-the-wheel instruction.
7. 30 minutes per session, 60 minutes per day is the maximum a student may drive in one day.
8. The minimum number of times a student will drive in a dual control automobile during the entire course without simulation or range is 12.
9. A maximum of 360 minutes of range instruction may be substituted for behind-the-wheel instruction.
10. All driver education instructors, with the exception of behind-the-wheel instructors, must hold a valid Iowa secondary teaching license and the Driver Education endorsement.

In the unfortunate event of an accident/collision with a student behind the wheel, Triple 'R' will ask that the student or family of the student cover half of the deductible for collision repairs (\$500.00 deductible for collision insurance; \$250.00 responsibility to student or student's family).

It is our intent that all students will complete the course at program's end. However, students with excessive absences, tardies, deficient driving abilities or disruptive behavior (as judged by the instructor) will be dismissed from the program or be required to obtain more driving experience before being issued a certificate of completion. Additional driving experience may be obtained with the instructor or other persons meeting state requirements as at the discretion of the instructor. Additional driving with the instructor will be \$40.00 per hour.

Upon completion of the course, students will be awarded a certificate of completion. The certificate will allow them eligibility for an intermediate driver's license under the Graduated License System of the state of Iowa, and also allow them eligibility for a school permit (if eligibility criteria are met). All other Graduated License requirements must be met (see graduated license information from the Department of Transportation). Lost certificates of completion can be duplicated with a \$40.00 fee.

Any student not showing up for their scheduled drive during the course of drivers education will be subject to a \$40.00 fee.
